TPG Biotech GenPar Advisors is the general partner of TPG Biotechnology GenPar, L.P., a Delaware limited partnership, which is the general partner of TPG Biotechnology Partners, L.P., a Delaware limited partnership ("<u>TPG Biotech</u>"), which directly held shares of Common Stock of the Issuer (the "<u>TPG Biotech Shares</u>"). TPG Ventures GenPar Advisors is the general partner of TPG Ventures, L.P., a Delaware limited partnership ("<u>TPG Ventures Shares</u>") and, together with the TPG Biotech Shares, the "<u>Shares</u>"). Because of Group Advisors' relationship to the TPG Funds, Group Advisors may have been deemed to have beneficially owned the Shares.

David Bonderman and James G. Coulter are officers and sole shareholders of Group Advisors, and may therefore have been deemed to have beneficially owned the Shares. Messrs. Bonderman and Coulter disclaim beneficial ownership of the Shares except to the extent of their pecuniary interest therein.
